JOB TITLE: Carpenter Journeymen, Apprentices, Skilled Labourers, & Tradespersons

ABOUT THE PROJECT

Summary of the project opportunity.

- Synergy Projects Ltd., a commercial general contractor based in Edmonton, AB, is currently leading construction of a new recovery community on behalf of the Blood Tribe Department of Health, Alberta Infrastructure, and the Government of Alberta. The project site for this new facility is located across the highway from the UFA card lock in Cardston, AB.
- Currently, to support construction of the project, we are looking to hire for multiple Carpenter,
 Apprentice, Skilled Labourer, and Tradesperson positions from within the Blood Tribe community.
- Work hours would be standard, full-time hours (based on a 44-hour work week) for the duration of construction, which is expected to run for approximately 18 months.
- Competitive wages will be offered for these roles based on individual skill levels and certifications.

SUMMARY OF POSITIONS

Describe the primary purpose of this job.

CARPENTERS & APPRENTICES

- Carpenters construct, erect, install, maintain, demolish and repair structures and components of structures made of wood, wood substitutes, lightweight steel, concrete and other designated materials for structural and architectural components. They are expected to perform their tasks within expected timelines and to accepted quality specifications.
- Level of responsibility and task assignment is contingent upon experience and training.

SKILLED LABOURERS & TRADESPERSONS

- Skilled Tradespersons perform construction activities relating to their specific scopes of work and area of specialization.
- Construction labourers assist skilled tradespersons and perform labouring activities at construction sites.





DUTIES AND RESPONSIBILITIES

Level of expectation related to duties and responsibilities increases with experience and education.

CARPENTERS & APPRENTICES

DUTY OR RESPONSIBILITY: General Activities

- Apply Occupational Health & Safety Act, Regulation and Code and company safety policy related to all aspects of construction.
- Read and interpret blueprints, drawings and sketches to determine specifications and calculate requirements.
- Prepare layout in accordance with building codes and project specifications.
- Maintain, repair and renovate residential, commercial and light industrial structures.
- Perform other activities at construction sites, as directed.

DUTY OR RESPONSIBILITY: Rough Carpentry

- Measure, cut, shape, assemble and join materials made of wood, wood substitutes, lightweight steel, concrete and other designated materials for structural and architectural components.
- Build foundations, install floor beams, lay subflooring and erect walls and roof systems.
- Mix, pour, spread, level construction materials.
- Perform construction/renovation/demolition activities.

DUTY OR RESPONSIBILITY: Finish Carpentry

- Fit trim and install trim items, such as doors, stairs, cabinetry, molding and hardware.
- Install architectural materials and components as required, flooring, wall coverings, etc.

DUTY OR RESPONSIBILITY: Site Work

- Mix, pour, and spread construction materials.
- Perform construction/renovation/demolition activities.
- Erect and dismantle concrete forms, scaffolding, ramps, catwalks, shoring and barricades as required.
- Operate equipment, secure special attachments to equipment, signal operators to guide them in moving equipment and provide assistance in other activities.
- Perform and coordinate drilling and excavating activities at construction sites as required.
- Level earth to fine grade specifications using rake and shovel
- Coordinate and perform tasks for demolishing buildings using prying bars and other tools, and sort, clean and pile salvaged materials.
- Remove rubble and other debris using rakes, shovels, wheelbarrows and other equipment.
- Operate pneumatic hammers, vibrators and tampers as required.
- Tend site machines or equipment used in construction such as mixers, compressors, pumps and heaters. Perform basic maintenance related to their operation.
- Clean up construction debris and remove materials to refuse container.
- Oil and grease construction mobile powered equipment as required.
- Direct traffic at or near construction sites.
- Use a variety of tools and equipment to complete the assigned construction tasks.





SKILLED LABOURERS & TRADESPERSONS

DUTY OR RESPONSIBILITY:

- Load and unload construction materials and move materials to/around work areas.
- Erect and dismantle concrete forms, scaffolding, ramps, catwalks, shoring and barricades required at construction sites.
- Mix, pour and spread materials such as concrete, asphalt & other construction materials.
- Assist tradespersons, carpenters & apprentices in construction/renovation/demolition activities.
- Assist heavy equipment operators to secure special attachments to equipment, signal operators to guide them in moving equipment and provide assistance in other activities.
- Assist in aligning pipes and perform related activities during oil and gas pipeline construction.
- Assist in drilling and excavating activities at construction sites.
- Level earth to fine grade specifications using rake and shovel.
- Assist in demolishing buildings using prying bars and other tools, and sort, clean and pile salvaged materials.
- Remove rubble and other debris at construction sites using rakes, shovels, wheelbarrows and other equipment.
- Operate pneumatic hammers, vibrators and tampers as directed.
- Tend site machines or equipment used in construction such as mixers, compressors, pumps and heaters as directed.
- Clean up construction debris and remove materials to refuse container.
- Oil and grease construction mobile powered equipment as directed.
- Direct traffic at or near construction sites.
- Perform other activities at construction sites, as directed.
- For Skilled Tradesperson roles, complete specific construction and installation activities for specialized scopes of work within area of expertise (e.g. roofing, siding, mechanical, electrical, etc.).

DECISIONS AND AUTHORITY

What kind of authority or decisions can this role make? What kinds of decisions or recommendations are referred to a higher level?

CARPENTERS & APPRENTICES

- Decisions are contingent upon training and experience.
- Journeyman, carpenters and apprentices are expected at a minimum to assume responsibilities appropriate to the tasks assigned to them.
- Individuals may be required to assume supervisory roles regardless of training or years of experience.

SKILLED LABOURERS & TRADESPERSONS

 Exercise judgment and refer to workers in authority for site decisions that are outside the scope of the assigned task.





QUALIFICATIONS REQUIRED

Describe the typical level of education and specialized fields of study required for this role.

CARPENTERS & APPRENTICES

- Journeyman Carpenter minimum of 4 years' experience and completion of 4th period apprenticeship training, Journeyman and Interprovincial Red Seal certifications.
- Non-ticketed Carpenter minimum of 7 years' experience.
- 4th Year Apprentice minimum of 3 years' experience and completion of 3rd period apprenticeship training.
- 3rd Year Apprentice minimum of 2 years' experience and completion of 2nd period apprenticeship training.
- 2nd Year Apprentice minimum of 1 year of experience and completion of 1st period apprenticeship training.
- 1st Year Apprentice demonstrated aptitude for the carpentry trade.
- WHMIS & CSTS09 training are required.
- Other construction and safety certifications are an asset but are not mandatory.

SKILLED LABOURERS & TRADESPERSONS

- Flag person may require a traffic control certificate.
- WHMIS training is a requirement.
- CSTS09 training is required. Workers without this training can receive it after employment.
- Other construction certifications would be an asset but are not mandatory.

Note: Prior to the company safety and HR orientation with Synergy, prospective employees will complete a fit for hire assessment from a contracted medical service.

KNOWLEDGE, SKILLS AND ABILITIES

Describe specific technical/specialized skills or experience required to perform this role.

CARPENTERS & APPRENTICES

- All knowledge and skill should be consistent with level of training and years of experience.
- Basic computer knowledge and skills are required. (Word processing, spreadsheet & email)
- Knowledge of equipment, materials & supplies associated with construction, maintenance and demolition.
- Knowledge of the applicable methods and procedures involved in the safe handling and storage of construction equipment and supplies.
- Ability to effectively supervise the daily ongoing activities of a workforce, attendance management and
- A working knowledge of Occupational Health and Safety compliance, company safety programs, safety policy & procedures. In addition, the ability to effectively apply and communicate with others on matters related to safety.
- Skilled in the operation of materials handling vehicles and associated equipment.
- An understanding of the proper lifting techniques (manual and mechanical).
- Demonstrate the proper safety procedures as set out in the OH&S and company safety manuals.
- Kev areas of competency include:
 - Problem solving analyze problems and make sound decisions or recommendations in a timely manner based on objectives, risk, implications and cost.





- Organization utilize strong organizational skills.
- Communication Display strong written and oral communications skills in English and employs effective listening skills.
- o Interpersonal Skills tactful and mature.
- Teamwork working together to achieve common goals.

SKILLED LABOURERS & TRADESPERSONS

- Construction task skills and knowledge would be an asset.
- Communication skills, ability to speak, read, write and understand English required.
- Ability to work as part of a team.
- An understanding of OH&S and corporate safety policy and procedures is an asset.

WORKING CONDITIONS

Describe all environmental conditions that affect this position. (Lifting, bending, exposure to hazardous materials, sitting for extended periods, computer work, etc.)

- Able to independently travel to assigned job site to meet scheduled hours of work
- In and out-of-town work assignments exist and may require a valid driver's license and suitable vehicle.
- Year-round construction activities, summer, fall, winter, & spring conditions.
- Interior and exterior work environments.
- There is an expectation that workers will have to work while utilizing the appropriate PPE for the tasks assigned in accordance with Synergy policies and the Occupational Health and Safety regulations.
- Workers may be exposed to hazardous environments and expected to handle hazardous materials.
- Construction tasks are physically demanding and repetitive and include, but are not limited to the following:
 - Reaching, carrying, pushing, pulling, bending, rotating standing, walking climbing, crawling, etc.
 - Forces on the body ranging in intensity from light to very heavy, and duration may be short or for extended periods.
